



On the 6<sup>th</sup> July 2023 around 2:00 PM a group of Meitei miscreants looted and vandalized all the properties from my rented house which is at the said place.

That, it is also worth mentioning that these criminal activities have caused agony and incurred a huge loss which is estimated Rs. 22,00000 (twenty-two lakhs) on ~~the~~

I was late in submitting this report as I was in different remote areas for months. Therefore, I earnestly request you to kindly register a zero FIR and book the perpetrators under the appropriate section of law.
