IN THE MATTER OF:-

A complaint petition under section 156(3) of the Code of Criminal Procedure, 1976 on behalf of the above named complainant for taking cognizance of the offences chargeable under sections 120-B, 406, 418 and 420 I.P.C. against the accused person.

DATE OF OCCURANCE:-

20-08-2023 and still continuing.

PLACE OF OCCURANCE:-

Lairikyengbam Salal Leikai, P.S. Heingang, Imphal East, Manipur.

CHARGEABLE SECTIONS:-

Under Sections 120-B, 406, 418 and 420 I.P.C. of the Indian Penal Code, 1860.

MOST RESPECTFULLY SHEWETH:-

1. That, the complainant is a resident of Lairikyengbam Salal Leirak, P.S. Heingang, Imphal East, Manipur. She is a domicile of the state of Manipur. As such, she is entitled to all the constitutional rights, privileges and protections guaranteed by the Constitution of India and the Laws & Acts for the time being in force.

3. That, the brief facts of the case leading to the filing of this present complaint case is set forth in the following paragraphs.

3.1. That, on 20-08-2023, the above named accused person came at the resident of the complainant along with her husband thereby requesting the complainant to hand over her jewellery items so as to enable her to attend a heijingpot and Luhongba ceremony of her relatives. Being a close acquaintance and also a relatives, the complainant hand over her jewellery sets consisting of (i) Nari 1 ½ sans, (ii) Ring 2 ½ sans, (iii) Gold chain (3 piece) 8 sans, 2 ½ sans, 2 ½ sans (iv) Bracelet 8 Sans and Big earring (2 piece) 8 sans each. The approximate value of the said jewellery items is about 7 lakhs.

At this juncture, mentioned may here be made that at the time of receiving the said jewellery sets, she assured the complainant that the same shall be handed to her within a period of 1 (one) weeks. However, after more than one month she neither handover the said jewellery items nor give any information about the same. As such, the complainant tried numerous phone calls to her mobile number, however, the same was un-responded. In the midst of it, the complainant came to learnt that the said jewellery sets was mortgaged to some unknown person for her personal used without the her knowledge.

3.2. That, the complainant telephonically as well as physically requested the accused person to handover the said jewellery items to her on many occasions. But the accused person deliberately avoided her by giving one reason or other and even ignored to respond the calls made by the complainant.

From the above facts and circumstances, it is crystal clear that the accused person in connivance with some other persons cheated the complainant thereby dishonestly inducing her to deliver the said jewellery items.

4. That, having no option, on 25-01-2024, the complainant lodged a report before the Officer-in-Charge, Heingang Police Station thereby requesting him to take up necessary legal action against the accused person and to punish her according to the law of the land. However, no action has been taken up till date.
5. That, being aggrieved on the failure of the Officer-in-CHARGE, Heingang Police Station to take up necessary action against the accused person, the complainant made a report to the Superintendent of Police, Imphal East District, Manipur in compliance of Section 154 (3) of the Code of Criminal Procedure thereby requesting to initiate proceedings as per law against the accused person. However, no action has been taken up against the said accused person till date.
6. That, the cause of action for filing the present complainant against the accused person arose on 20-08-2023 when she took the jewellery items from the complainant and the same is still continuing within the territorial jurisdiction of this Hon'ble Court.
7. That, the acts of the accused person shows her total disregard for the established laws of the land and she is required to be shown that no one, however rich or influential or powerful, are above the law of the land.  
At this juncture mentioned may here be made that, if no action has been taken against the accused person, the complainant shall suffer irreparable loss and injury which cannot be compensated in terms of money. Moreover, the mischievous act of the accused person will continue other individuals as well if no action has been taken her in time.
8. That, owing to the said acts of the said accused person, the complainant is at a loss thereby affecting his future course of earning for his livelihood and extremely aggrieved at the gross injustice that has been perpetrated against her by the accused person. She has no other remedy for the same except to approach this Hon'ble Court by filing this complaint petition praying for adequately redressing her genuine grievances.
9. That, the Hon'ble Court has the jurisdiction to entertain the present complaint petition as the said offences were committed within the territorial jurisdiction of this Hon'ble Court.
10. That, the complainant will rely upon the documents which are annexed hereto.

#### PRAYER

It is, therefore, prayed that the Hon'ble Court may be pleased to:-

- i) take cognizance of the offences under Section 120-B, 406, 418 and 420 IPC against the accused person and her accomplice;
- ii) pass an order thereby directing the Officer-in-charge, Heingang Police Station to take up necessary action against the accused person thereby registering FIR against her;
- iii) pass an order thereby directing the Officer-in-Charge, Heingang Police Station to recover the said jewellery items from the accused person;
- iv) issue warrant of arrest against the accused person and her accomplices;
- v) try and punish the accused person and her accomplices according to law; and
- vi) pass any other directions or orders as the Hon'ble Court deem fit and proper in the present case.

And for which act of kindness your humble complainant shall, as in duty bound, ever pray.
