



2. That on 4<sup>th</sup> May 2023 at 4 pm, a huge contingent of Armed radical/ Meitel, Arambai Tengol and Meitel leepun attack our village and in the process looted and Vandalized properties.

3. That the above said criminals with there in humane activities have causes me grave mental agony. Notwithstanding the fact that, there unruly activities have made me great loss enormous wealth estimated to be Rs 21 Lakhs.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at L. Phainom Village, Churachandpur.

So, I could not make the said report on time due to the present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
