



1. That, I, Thanglalching Haokip Aged 42 S/O Jamkhotinsei Haokip belong to KUKI Community, a schedule Tribe recognized under the constitution of India Whereby, I am staying in a rented house New Lambulane 1<sup>st</sup> Street P.S: Porompat, District: Imphal East. *House owner paogalet Touthang*
2. That on 4<sup>th</sup> May, 2023 at around 4.30pm, a huge contingent of Armed radical/ Meitei, Arambai Tengol and Meitei leepun attack our Locality and in the process looted and Vandalized properties.
3. That the above said criminals with there inhumane activities have causes me grave mental agony. Notwithstanding the fact that their unruly activities have made me great loss enormous wealth estimated to be Rs 15 Lakhs.
4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at B.Aijalon Village, Churachandpur District.

So, I could not make the said report on time due to the present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
