FIR:DISRUPTIONS INTO ARMY COLUMN IS DUTY BY UNKNOWN/UNIDENTIFIED MISCREANTS OF THAMNAPOKPI, YKPI, SABUNGKHOK KHUNAO, MUIREI & LAMLAI VILLAGES

1. Security Forces columns were deployed for Internal Security Duty in general Area Semol and Saibol villages on requisition of State Government for protection of civilians and maintaining peace in the area. In the past, there had been incidents of indiscriminate firing between the warring groups at these locations on 12 Sep 2023, 12 Oct 2023 and 25-26 Dec 2023, where after the Indian Army columns were deployed to prevent any serious damage to life and destruction of property.
2. On 13th Feb 2024 at 1020 hrs, miscreants from Khamanlok Gwalabi Hts in Approx 150 numbers, allegedly attacked three locations of YKPI Bowl namely Kuki Vill of Saibol, Kuki Vill of Twichin and Army Post at Semol. They had crossed over from Khamanlok Bowl. Further, the reinforcements of the security forces were prevented from reaching the location by unlawful assembly of Meira Paibis in approx 800 numbers of Thamnepokpi, YKPI, Sabungkhok Khunao, Muirei & Lamlai, who had blocked the routes towards the incident site.
3. When Kuki community dominated Saibol Village was under attack, Army Column from Semol was rushed to save the village & its villagers. Saibol was under heavy fire of miscreants from three directions & villagers were hiding to save their lives. When the Army column of 20 JAT moved inside the village Saibol, unidentified miscreants fired at the Column of Army led by Subedar Mohan Ram JC. No. 492279P who sustained a gunshot wound. When individual was being evacuated by road, an unlawful assembly of Meira Paibis blocked the evacuation column at Thamanapokpi thereby prevented evacuation. Indian Army troops moved through alternate route & evacuated the casualty to helipad almost 10kms away from the site of injury.
4. The act of indiscriminate firing was done with a clear intent to cause death and with the knowledge that such an act was so imminently dangerous that in all probability it would cause death of the individual to whom grievous hurt was caused and further to cause substantial damage to life and property. Further, the act of the unlawful assembly to block the routes was intended to facilitate the escape of miscreants as well as to prevent the evacuation of an injured soldier.
5. The intentional and indiscriminate firing by the miscreants in general area Semol and Saibol villages and blockade by the Meira Paibis on 13th Feb 2024 was unlawful, violent, and amounted to several cognizable offences under the Indian Penal Code (IPC), 1860. They fired indiscriminately with the deliberate intent to kill. The said individuals may immediately be identified and arrested to prevent them from giving effect to any such further violence.

6. Further, it is requested that FIR against unknown/ unidentified miscreants who indiscriminately fired in general Area Semol and Saibol villages, may be lodged for the following offences: -


- (a) Attempt to murder contrary to **Section 307 of the Indian Penal Code, 1860.**
- (b) Voluntarily causing grievous hurt by dangerous weapons or means contrary to **Section 326 of the Indian Penal Code, 1860.**
- (c) Attempt to commit culpable homicide contrary to **Section 308 of the Indian Penal Code, 1860.**
- (d) Voluntarily causing hurt, if the hurt which he intends to cause or knows himself to be likely to cause is grievous hurt and if the hurt which he causes is grievous hurt contrary to **Section 322 of the Indian Penal Code, 1860.**

7. Further, it is requested that FIR against unknown/ unidentified rioting Meira Paibis & other rioters in general Area Thamnapokpi, YKPI, Sabungkhok Khunao, Muirei & Lamlai village may be lodged for the following offences :-

- (a) Obstructing Public Servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to **Section 353, 503, 504, 505 and 506 of the Indian Penal Code, 1860.**
- (b) By voluntarily obstructing any public servant in the discharge of his public functions contrary to **Section 186 of the Indian Penal Code, 1860.**
- (c) By disobedience to an order lawfully promulgated by a public servant, if such disobedience causes obstruction, annoyance or injury to persons lawfully employed contrary to **Section 188 of the Indian Penal Code, 1860.**
- (d) Criminal Intimidation, Assault and Criminal Force against Public Servants discharging public duty in Aid to Civil Authorities contrary to **Sec 34, 120, 350, 353 and 332 of the Indian Penal Code, 1860.**
- (e) Instigating and abetting the Unlawful Assembly of rioting Meira Paibis and locals to obstruct the Army in performance of their lawful duty on 13 Feb 2024 contrary to **Section 34, 120, 353, 505 and 147 of the Indian Penal Code, 1860.**
- (f) Assault or criminal force otherwise than on grave provocation contrary to **Section 352 of the Indian Penal Code, 1860.**
- (g) By assaulting or using criminal force to any person being a public servant in the execution of his duty as such public servant or with intent to prevent or deter that person from discharging his duty as such public servant contrary to **Section 353 of the Indian Penal Code, 1860.**
- (h) By intentionally insulting with intent to provoke breach of peace contrary to **Section 504 of the Indian Penal Code, 1860.**

8. The Hon'ble Supreme Court in Lalita Kumari Vs Govt of UP (MANU/ SC/1166/ 2013) has held "It is mandatory to file the FIR u/s 154 of the Code if the information discloses the commission of a cognizable crime and no preliminary investigation is permissible in such a case". In deference to the Hon'ble SC ruling, you are requested to register a First Information Report against the above-mentioned persons.

9. It is requested that action taken post registering of FIR and identification as well as initiation of legal action in respect of perpetrators of above crimes be intimated in laid down time frame (without waiting for invoking of the provisions of the Right to Information Act, 2005). A copy of the FIR and the police report on completion of the investigation in terms of **Section 173 (2)(ii) of the Criminal Procedure Code, 1973** may please be provided to this office for our records please.
