



Subject: Report on looting, Vandalism and burning down of properties. (House) Officer in-charge

Sir,

With due respect, I am to report that on 04/06/2023 at around 1:30 a.m, a large group of Meitei miscreants attacked my house where me and my family (husband and son) rented the house of Seilen Haokip at Pureiromba leikai, Chassad Avenue Imphal. The criminals forcibly opened the gate and destroyed, vandalized, looted my house and burnt down all my belongings as noted below.

List of properties which were damaged, looted and burnt down are as follows:

1) New Bench Set with cushion worth	Rs 80,000/-
2) 2 wooden Bed	Rs 60,000/-
3) Gas Box (stove and two cylinders)	Rs 20,000/-
4) 4 Tables worth	Rs 30,000/-
5) 2 wooden Almirah and one Steel Almirah worth	Rs 90,000/-
6) Gold Necklace Worth	Rs 90,000/-
7) Two Mattress and Blanket 7 pieces worth	Rs 80,000/-
8) Two Laptops and one TV Worth	Rs 1,30,000/-
9) Utensils Worth	Rs 80,000/-
10) Clothes and Dresses Worth	Rs 1,50,000/-
11) Syntax 3 pieces worth	Rs 10,000/-
12) Solar Plate and Battery worth	Rs 50,000/-
13) Washing Machine and Refrigerator worth	Rs 50,000/-
14) Family Library worth	Rs 50,000/-
15) Miscellenous (Jumbo boxes, plastic container, storeys etc)	Rs 10,000/-
Grand Total worth	Rs 9,80,000

I, theretore, requested to kindly take up necessary legal action against the unknown culprits. Cause of delay in reporting on time is due to displacement and volatile law and order situation.
