



Subject: Report on Arson.

Sir,

I have the honour to state that on 04/01/2024 at about 6 pm, my residential Building (2-storeyed) at New Lambulane, 3 rd street., under Patta No. 647 (New) was burned down by unknown Meitei miscreants, after trespassing. In that, the building along with properties inside were burned to cinders. The value of the burned Building is estimated to be Rs. 7,000,000/- and Rs. 612000/- for the properties inside, In total 7612,000/-
I along with my family had escaped and left my residence on 4/5/2023 and now took refuge at Chengkonpang, Churachandpur. The matter was circulated in the news/media.

I belonged to Thadou tribe which is a recognized Tribe in India.

It is therefore requested to kindly take up necessary legal action against the unknown accused persons. Cause of delay in reporting is due to my displacement and ill health.
