

Subject : Report on vandalism and looting of properties.

Sir,

With reference to the above cited subject, I have the honor to report to you as follows :

I, Lhingkhohat Kipgen aged about 64 years W/o Lhunkhothang Kipgen of New Lambulane 1<sup>st</sup> Street, Imphal Municipal Council, Imphal East District, PS – Porompat.

That, on the 3<sup>rd</sup> of May 2023, due to the ethnic violence in the state, my family and I had to run for our lives, leaving behind all our belongings. We sought shelter at the Mantripukhri Assam Rifles Camp. Unfortunately, during this time, unknown Meitei miscreants looted and vandalized all my properties.

However, I came to learn from my neighbourhood that all my properties have looted and vandalized by the said miscreants, on the 4<sup>th</sup> of May 2023 at 7: 00 p.m.

It is also worth mentioning that these criminal activities have caused grave mental agony and incurred a huge loss estimated at about Rs.70 lakhs only.

Fortunately, I and my family managed to escaped from the violence, and now currently taking at Molnom, Churachandpur.

I was late in submitting this application as I was in different remote areas for months.

Therefore I earnestly request you to kindly register a ZERO FIR and book the perpetrators under the appropriate section of law.
