



Respected Sir,

With due respect, I would like to put a few lines regarding anti-social elements, attacking, vandalising, looting and burning of 5 houses on January 4, 2024 at around 9:15 pm at New Lambulane under Porompat Police Station, Imphal East District, Manipur-795005 by unknown miscreant belonging to Meitei Community amid the presence of heavy security.

That, I Kaiminlien Guite aged about 29 years, S/o. Otngam Guite presently staying at Saihenjang Village, Tuibong Sub-Division Churachandpur.

That, on May 5, 2023 at around 4:30 pm, due to the ethnic violence in the state, I (me) and my family have to run for our lives leaving behind our **rented house** along with all our household items and belongings at the above mentioned address owned by Mr. Haomang Vaiphei..

That, It may be reported that in the said incident, the unknown miscreant forcefully enter, destroy, and looted my rented house in which properties consist of valuable items, documents such as Voter ID's, pension's related papers, memento for retirement etc., books & materials, computer which contain important files that can be misused in future, savings (in cash), newly bought electronic products, clothes, furniture's, kitchen items and others.

In the above facts and circumstance, therefore respectfully requested to your good office to take up necessary legal action and register an **FIR / ZERO FIR** against them for the interest of justice.
