



Subject :- Report on Looting, of house, household items/assets. and Discrimination of Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, **Ngamgoulen Touthang** aged about 19 years S/o **Jangkholet Touthang** . Belonging to the **Any-Kuki Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Resident of **Konung Mamang near Govindaji Temple, Imphal- West Manipur. P.O.&P.S., Prompat.**
2. That, due to the ethnic violence in the state, I and my sister left our Rented house at the above mentioned address owned by **CH Kamani Devi**. And in the process some unknown miscreants looted our rented house including all our household items. ^{East} on 15 June 2023 at @ 11am.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.5,77,000/- (Rupees Five Lakhs Seventy Seven Thousand) only.**
4. Fortunately, I managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at **Silak Village Churachandpur** .
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned place. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
