Today i.e. 27/02/2024 at 09:20 pm received a reliable information, that on the same day at around 09:10 pm a large number of unknown armed Kuki militant starting firing of automatic weapon from the hill side of Urangpat towards Thamnapokpi, Sanasabi village. At the same time from the hill side of Thamnapokpi Uyok Ching the Kuki militants firing several rounds of automatic weapon towards Thamnapokpi, Shantikhongbal and Sabungkhok Khunou village. The Yaingangpokpi Police team rush to the Thamnapokpi village to defence the heavy gun attacked and to protect the lives of the villages and properties. The Police officers and personnel were retaliated firing of AK rifles- 484 rds, Insas rifles- 394 rds, SLR rifles- 63 rds and 303 rifles- 215 rds. In the Kuki militants also attack heavy firing towards Police team with bombs. The intermitted exchange of firing took place till 07:30 am of 28/02/2024. Fortunately no causality report received.

In this regard the OC/YPI-PS registered a case under FIR No. 11(02)2024 YPI-PS, U/S: 307/400/34, 25(1-C) A. Act & Sec 5 Explosive Sub. Act.
