



I have the honour to report that on 2/2/2024 at about 6:18 pm, some unknowns persons around 13 in numbers in that one who identified himself as the members of K.C.P Brojen @ City Meitei Group had forcibly attacked our main gate and also destroyed two CC TV cameras installed at the gate located Porompat Khongkham Leikai. Besides, in the earlier of the dated 3/12/2023 the above mentioned K.C.P City Meitei group had demanded a huge amount of Rs 20,00,000/- (Rupees Twenty Lakhs) through mobile phone bearing numbers 8730035343 & 9233594538. In which they had threatened my wife that they will kill her if they failed to pay their demanded amount.

It is therefore, requested to kindly take up necessary legal action against them as they had threatened the life of my family members and had destroyed my properties according to law.
