Sir,

With due respect, I have the honour to report that today i.e. 20/03/2024, at about 2:00 p.m. teams of CDO Imphal East Unit led by Inspt. Kh. Henery Singh, Officer-in-Charge, Commando Imphal East Unit along with a column of 1/3 GR Maphou Dam and teams of SDPO Lamlai, Imphal East District, OC Maphou Dam Police Station and Reserve Line, Imphal East District in the general area Songphil-Laikhong ridges and its surrounding areas under the command of Shri. Kh. Herojit Singh, MPS Addl. SP (Ops) Imphal East District and under the overall supervision of Shri. K. Meghachandra Singh, MPS, Superintendent of Police Imphal-East District.

First, the combined team conducted the searched operation in the general area of Songphil-Laikhong village and retrieved the sand mining trucks which were burnt on 17 March, 2024 by the suspected armed Kuki militants. Then, the combined team dominated the area by conducting foot patrolling and blocking all the possible escaping routes and by-lanes. Further, the combined team retrieved the burnt vehicles from the said village and conducted searched operation to the said villages and its surrounding areas.

In that, the combined team found and recovered a large nos. of arms and ammunitions which were abandoned war like stores at a place about 100 meters north to the area where the vehicles were burnt down. The same were seized from the spot i.e. 100 meters north of Keihao village at 2:30 p.m. by observing due formalities.

Further the combined team continued the searched operation at Nungmanbi/Pheija village located between Keithelmanbi and Laikhong Village, Kangpokpi District. In that the combined team recovered the undernoted arms, ammunitions, explosives from Nungmanbi/Pheija Village:
