




Subject: - Report on looting of household items/assets, illegal occupancy, and discrimination of Scheduled Tribes.

Sir,

With reference to the subject cited above, I am to bring to your kind attention the following points having a direct bearing on the issue at hand: -

1. That I, **Paulienkham Vaiphei**, aged about 54 years, belong to the Vaiphei Tribe/Community, a Scheduled Tribe recognised under the Constitution of India, by virtue of which I am entitled to protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **Chassad Avenue, near Officers' Colony, Sanjenthong, P.O. & P.S. Porompat, Imphal, Manipur**.
2. That, at about 8 AM on the 4th of May, 2023, my family and I had to evacuate our home in fear of our lives following the eruption of ethnic violence in the state, leaving behind all our worldly possessions and household items. In the process some unknown miscreants have looted our house.
3. That, the looting of our house has inflicted grievous economic loss upon my family to the tune of approximately **Rs. 30,00,000/- (Rupees thirty lakhs)** only.
4. Fortunately, my family and I managed to escape from the violence and now have taken refuge in **Tuibong, Khopi Veng, Churachandpur, Manipur**.
5. That, it has been reported to us that certain people have illegally occupied our home and property at the address mentioned in Para 1.



That, I am filing this information at a late juncture because I apprehended a grave danger to the physical safety of my family and myself which rendered it difficult for me to take appropriate action. Further delay in filing this information was occasioned by my ill health on account of which my freedom of movement was severely circumscribed. However, now that I have regained my health, I am enabled to file this report.

Accordingly, I humbly pray for your indulgence in allowing me to kindly register an FIR/ZERO FIR to investigate the matter and hold the perpetrators to account as per the prevailing law of the land, for which I will ever remain thankful.
