



Subject: FIR regarding Burning and Structural damage of my house at Elim Villa,
Jehova Yire Complex, Haokip Veng, Imphal by unknown miscreants on 5th May,
2023.

Sir,

I, Smt. Lucy Haokip, 40 yrs wife of Shri Seiminthang Lenthang, am a resident of Elim Villa, Jehova Yire Complex, Haokip Veng, Imphal. This is for kind information that during the Mob-violence in Imphal, my residence at Elim Villa, Jehova Yire Complex, Haokip Veng, Imphal had been burned and vandalized by unknown miscreants on 5th May, 2023 at around 11 am.

It was around 7:00 pm to 8:00 pm on 03-05-2023 that mobs gathered in large numbers in and around Imphal area. There were sounds of explosion from time to time throughout the night of 03-05-2023 and 04-05-2023. My family and myself fled the premises of Elim Villa, Jehova Yire Complex, Haokip Veng, Imphal on 04-05-2023 to take shelter at CRPF camp, Lamphel.

The damage caused by the mob violence has rendered the structure inhabitable. The estimated value of my residence at Elim Villa, Jehova Yire Complex, Haokip Veng, Imphal is about Rs. 62,31,000/- (Rupees Sixty two lakhs thirty one thousand only).

I would like to report the estimated loss as follows:

1. Residential Structure damage to be more than 80% - Rs. 50,00,000/-
2. Electrical and sanitary fittings more than 90% - Rs. 9,00,000/-
- Total - Rs. 59,00,000/- (Rupees Fifty nine lakhs only)

As such, I would like to register an FIR against the perpetrators and request you to take befitting actions against those responsible for the crime.
