Sir,

I have the honour to report that today i.e. 04/02/2024 at about 6:30 pm, self along with police teams including women police is deputed for maintaining law and order, round checking/patrolling, frisking & checking so as to prevent any anti-social elements at New Checkon, New Lambulane, 1st Street, Tribal market Imphal East so also for peaceful co-existence in the state.

During the frisking and checking at New Lambulane, 1st street, Imphal East District, two unknown person were caught red handed while stealing property from a house of New Lambulane, 1st street. Later, the duo unknown persons was identified as 1) Khulakpam Arshad Sareef (25) S/o. Balibur Rahaman of new Lambulane, River side and 2) Rizawana (24) D/o Liyakat Ali of K.R Lane, near K.R Lane Church, Imphal East District. Accordingly, both the accused person were arrested at the spot i.e. New Lambulane, 1st street, Imphal East District at about 7: 50 pm and 2(two) nos of suit case containing some clothes were also seized at the spot from the above duo accused at about 7:55 pm and brought to Porompat Police Station for further legal action.

It is therefore, requested to kindly take up necessary legal action against the two arrested persons according to law.
