

Sir,

I have the honour to report that, on 26/03/2024 at about 6:00 am a reliable input was received regarding weapons cache. Accordingly, a combined team comprising of CDO teams of Imphal East led by Shri Kh. Herojit, MPS, Addl. SP (OPS) Imphal East along with Officer in Charge of SMG-PS and his team, a column of 22- Assam Rifle, 2-sections of G/4 Bn. CRPF under the supervision of Shri K. Meghachandra Singh, Superintendent of Police, Imphal East launched an Cordon and Search Operation (CASO) at 8:30 am at Utonglok village. During the search operation, the undernoted arms, ammunition, explosive etc. are found suspecting to be concealed by miscreants at the foothill of Utonglok village


1. 1(one) No. of 9mm US made M-1 Carbine Machine Gun without Magazine marked as 300.
2. 1(one) No. Tear Gas Gun marked Prahari MK-II (Regn.No. 2K5-11233 & But No. 192.
3. 5(five) Nos. of 9mm live rds.
4. 1(one) No. tear Gas Shell (live Rd.) lot No. 17.
5. 9 (nine) Nos. Tear Gas fired Cartridge cases.
6. 3 (three) Nos. of 36 Hand Grenade without detonators.

Accordingly, the above items are seized from the foothill of Utonglok village at 9:40 am by observing formalities. The operation was concluded at 10:30 am of the same day.

The seized articles along with the seizure memo are handed over to your good office for taking further legal proceeding.


