




Dear Sir,

I have taken Banks' lease accommodation at New Lambulane 1st street, Imphal East under Porompat Police Station. That, on 3rd May, 2023 ethnic clashes between Meitei and Kuki erupted. Accordingly without taking out anything my family members run for their life to the nearest AR Camp for safety.


Now that the Arambai tenggol, UNLF and Meitei Leepun having been given free movements with arms and ammunition in the heart of the city, started burning houses situated at New Lambulane, looted and stolen my scooty and my Swift Dzire car bearing registration no.MN01S 8442, Engine No.1477654 and all the household items estimated to be about Rs.29 Lakhs.

I therefore, earnestly request you to kindly take up necessary action immediately for the restoration of my properties and arrest/punish the culprits according to the law.


