Subject: Report

Sir,

With due respect, I have the honour to report that today i.e. 25/03/2024, at about 08:00 AM Team of 8 Bihar Regiment, 'A' coy led by captain Hitesh Janta ,officer in charge stationed at Thoubal Dam Company Operating Base carried out an recovery operation. The team consisting of strength 12 from column of 8 BIHAR located at Thoubal Dam moved towards Maphou Bazar and Maphou Kuki Village at 0800 Hrs to check for presence of telltale signs of any cadre group in the Sensitive Zone of Imphal East District based on intelligence from local sources about likely presence of UG in the area. During the operation, deliberate search of area was carried out which included checking and search of abandoned places and periphery of Maphou Kuki village along hill bases and abandoned structures. During the search at under construction structures cordtex was found lying inside the vacated and under construction building. After deliberate search , war like stores were recovered from nearby places. Details of recoveries are mentioned below :


- I. Improvised mortar /country made launcher (6 feet)- 01.
- II. Bipod /mount -02 (1-big, 01- small)
- III. Base plate -01
- IV. Mortar ammunition /country made launcher live bomb -32
- V. Mortar ammunition round cap holders/ country made launcher ammunition round cap -05
- VI. Explosive (dynamite / TNT) -1.5 kg(approx)
- VII. Cordtex -1.5 meters
- VIII. .303 Rifle fired case -39
- IX. 7.62 mm AK 47 fired case -07
- X. 12 bore fired case -12
- XI. Lighters -02
- XII. Heroine (drugs )- 20 gms(approx)
- XIII. 36 Hand Grenade -02
- XIV. Pompie Mortar 03 feet -01
- XV. 5.56 mm INSAS Rifle fired case- 02

Thereafter, the above recovered arms, ammunition, explosives, drugs etc were seized from the spot i.e. Maphou Kuki village at 9:00 am and handed over to you for taking up further necessary legal procedures.
