Today i.e. 29/2/2024 at 09:55 pm received a reliable information that at around 09:50pm of date some heavily armed miscreants suspected to be kuki militants coming out from SOO designated Sinai camp located at Nomjang(Samushong) started firing from trenches and bunkers located at Thamnapokpi Uyok ching, Sangran and Kouneh etc. towards Thamnapokpi, Shantikhongbal and Yaingangpokpi villages using automatic weapons, bombs and other explosive substances with an intention to cause death, injuries, damage and destruction of properties of the said Meitei villages, as such villagers are being terrorized and fleeing/leaving their villages. In that CAPF (BSF) and police parties deployed at Thamnapokpi and Geetanjali Brick field, Sabungkhok Khunou retaliated by firing to protect the lives and properties of the villages. Later on reinforcement from DHQ/IE led by SP/IE along with Addl. SP (Ops)IE, teams of CDO/IE, Addl. SP(LO)IW with his CDO teams and Addl. SP Ops BPR with his CDO teams, teams of Kakching CDO, CDO/TBL and teams of 6 IRB arrived and assist the CAPF(BSF) and police parties. The firing and bombing continued sporadically and intermittently till 6.00 am of 1/3/2024.

Hence a case is registered on Sou Moto under FIR NO. 12(03)2024 YPI-PS,U/S 307/427/34-IPC, 25(1-C) A. Act & 6 UA(P)A. Act.
