With reference to the above subject, I the undersigned have the honour to state that on the 4th of May, 2023 unknown miscreants carried out massive attacked at Haokip Veng, Imphal East resorting to burning down of a number of houses and looting of properties.

2. Looted properties includes:

Sir,

- i) Electronic itmes such as 2 nos. of Desktop computers, 2 nos. of Canon printers, 2 nos of Laptop computer, Sony Smart TV (65 inches), 2 nos of Refrigerator of 165 and 200 litres respectively, Kent RO system, 2 nos of Wahsing Machine, Grinders, Oven, Induction etc. worth Rs. 6,80,000/-(Six lakhs eighty thousand only).
- ii) Furnitures such as 1 nos. of VIP Sofa-Set, 2 Nos. of wooden Sofa set, 6 nos of Godrej Steel Almirah, 4 nos. of wooden Almirah, 3 nos. Desktop Computer Table, TV Stands, Dining Table with 6 nos of chairs etc. worth Rs. 5,10,000/-(Five lakhs ten thousand only).

iii) Jewellery & ornaments itmes such as 5 nos. of traditional necklace(Khiba), 2 nos. of traditional rings, gold chains, necklace and ear-ring worth Rs. 3,50,000/-(Three Lakhs fifty thousand only).

- iv) Household items sucha as 4 nos. of Kings size beds, 4 nos of middle size beds, 15 nos of matress, about 60 woolen blankets, 4 nos. of bed boxes, cushion, utensils, water tanks(Syntax), garments belonging to our family, more than 100 nos. of traditional shawls etc. worth Rs. 7,50,000/- (Seven lakhs fifty thousand only).
- V) About 7 wooden Doors made of Teak worth Rs. 1,26,000/-(One lakh twenty six thousand only) have also been destroyed and looted.
- 3. One pucca constructed building worth Rs. 80,00,000/-(Eighty lakhs only) and another wooden constructed house worth Rs. 50,00,000/-(Fifty lakhs only) were also completely destroyed and burnt down as result of the said attacks on 4th May, 2023.
- 4. Altogether, properties and buildings worth Rs. 1,54,16,000/-(One crore fifty four lakhs sixteen thousand only) has been looted and destroyed on the above cited day.
- 5. The cause of delay in reporting is due to the sudden leaving of our residence and displaced from one place to another as there was no availability of proper place for accommodation and other basic needs.
- 6. It is therefore, requested to take up a necessary legal action as per the law of the land
