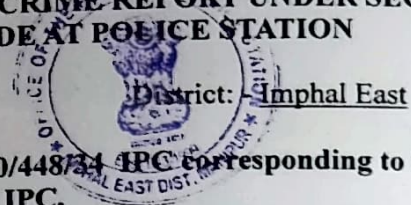



Subject: Lodging FIR over loss of properties

Sir,

With due respect, I beg to state that due to the current law and order situation, I, along with my family had to leave our residence along with all our properties in New Lambulane, 1st Street as it was no longer safe for us to stay. However in the month of May, after we left, our house was broken into several times and some valuable items such as Jewelleries, cash, mobile phones etc. were stolen. On the 10th June and the subsequent periods of July, August, September and November, 2023 unidentified miscreants suspected to be members of Arambai Tenggol, Meetei Leepun and other allied organisations/societies broke into our house, destroyed several properties and looted all our valuable belongings (both movable and immovable) along with several medicines and equipments in our Pharmacy on the ground floor.

The details and the approximate value of my property, either destroyed or looted, are hereunder:

Further, the reason for delay in lodging an FIR is due to non-confirmation of residential settlement.

In this regard, it is my earnest plea to kindly register a regular case and take necessary legal action according to the law at an early date.
