



I am directed to report to you about an incident of missing/stolen which came to light on 8<sup>th</sup> February, 2024 at JNIMS, A-Block.

1. AC Compressors (parts) of 34 units.
2. Electrical wiring.
3. Copper pipes (from compressors to Indoor AC Unit) which all were placed in 5<sup>th</sup> Floor of A-Block, JNIMS.
4. Some aluminium window frame and partitions which were placed in 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> Floor, A-Block, JNIMS.


