Subject: Lodging FIR over loss of properties

With due respect, I beg to state that due to the current law and order situation, I Sir, along with my family had to leave our residence along with all our properties in New Lambulane, 1st Street as it was no longer safe for us to stay. However, in the month of June after we left unidentified miscreants suspected to be members of Arambai Tenggol, Meetei Leepun and other allied organisations/societies broke into our house, destroyed several properties and looted all our valuable belongings (both movable and immovable). We had bought the plot of land for 75 lakhs after following due procedure with proper documentation. Thereafter, we build a new retaining wall costing around 20 lakh (including labour charges) and spent around 5 lakhs renovating the already existing house. Further, the reason for delay in lodging an FIR is due to non-confirmation of residential settlement.

In this regard, it is my earnest plea to kindly register a regular case and take necessary legal action according to the law at an early date.
