



Sir,

With due respect, I have the honour to state the following few lines before you for your kind consideration and necessary action.

That, I have settle at Palace Compound, Konung Mamang at near Advance Hospital at the rented house of one Reena Sapam. I have run a Grocery shop and Furniture house at Mahabali Kabui Khul.

That, due to the violence in Imphal and adjoining areas, I have left my rented home for my safety and my shop located at the rented house of one Joy Kumar Kamei was looted on the 4<sup>th</sup> May, 2023.

That, on dated 14<sup>th</sup> January, 2024 at around 11:00 am, it has again come to my knowledge that, miscreants belonging to Meitei community in the name of Arambai Tenggol have enter into my rented house and looted all my household properties. My two wheeler vehicle Vespa bearing Reg No. MN01AF 0121 and my Alto car bearing Reg No. MN01N 7831 was also looted away by the miscreants. Further, they have also looted my Furniture shop containing ready made doors, windows and other ready made items, 200 Pieces of wooden logs (all Teak).

The Total amount of looted and lost properties are estimated at Rs 90,00,000/- (Rupees Ninety lakhs) approx.

The incident could not be reported to my concern PS timely due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action in this regard.
