I am a scheduled tribe belonging to the Any Kuki Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of Twichin Village, P.O.- Litan, P.S- Saikul & district- Kangpokpi, Manipur.

That, on the 28th of May, 2023 at around 6:30 PM, we fled from our village to the near by hills, where we noticed a group of Meetei / Meitei miscreants mostly in Black-Combat dress suspected to be members of Arambai Tenggol and the locals in and around the area attacked our village and in the process they have vandalized, looted my household items/ movable properties and burnt/ arson attacked my house, that includes;
