That, I would like to mention here that, we watched the criminal activities that took place on our village from the near hill, the place where we took refuge at, in order to save ourselves from the said miscreants.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.20,00,000/- (Rupees Twenty Lakhs) Only, inclusive of my house and the household items/ movable assets.

That, the reason behind my late application is due to which I was at different remote areas, and I humbly pray you to kindly register a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
