



Today i.e., 27.2.2024 at 7:05 pm received information that on the same day at about 6:55 pm, some unknown armed persons led by Korounganba Khuman, Robin Mangang and Kanan of Arambai Tengol and other suspected to be member of unlawful organization has attempted to kill Addl. SP (OPs)/Imphal West Shri. Amit, MPS by firing toward his vehicle and residence at Wangkhei Tokpam Leikai, Imphal East District, Manipur. It is also learnt that the armed miscreants have abducted Shri Amit, MPS by attacking his escort team and snatched away some arms and ammunitions of his escort team along with his vehicle. During the attack, some vehicles and property of Shri Amit was damaged.

Hence, a suo-motto case under FIR no. 165(2)2024 PRT-PS u/s 307/365/379A/427/506/34 IPC, 16/20 UAP Act and 25(1-B)/ 25(1AB) A. Act is taken up for investigation.
