



No. MN05B-3740 having Chassis No. ME121E069A2017088 and Engine No. 21C6017134 registered in the name of my younger brother namely Kamei Lanjaigai s/o K. Solomon of Sangaiprou Kabuikhul along the Hatta road and met a self accident reaching at Hatta Minuthong near Oil Pump. In that, nearby one unknown male person helped me and hired me a vehicle for hospital. The said unknown person assured me that my motorbike would be kept in safe nearby a shop and also took the key of the bike. After I returned from hospital and asked by searching the person with my motorbike. However, the said unknown person escaped and not found with my motorbike without informing any anybody. The value of the said stolen vehicle is worth Rs. 75,000/- approx.
