Respected Sir,

I have the honour to report you that on date 12/05/2023, a group of people belonging to kuki tribe including Kuki militants group have entire at my house located at Dongsum Village, PS-Saikul, District - Kangpokpi, Manipur and have burnt, attacked and destroyed my house, asset and properties which left me and my family homeless. The mob was armed with spades, axes, Sticks and other deadly weapons. They also forcefully took away some domestic animals including 2 dogs,10 ducks,4 chickens etc. The approximate value of the burnt and lost items is about Rs. 10 lakhs. I along with my family members (my wife and 5 Childrens) fled from our house for survival and presently took sheltered at Andro Loupaochum girl's Schedule Caste Hostel relief camp.

I, request your good self to intervene in this matter urgently and protect our property and our life and limb from any further loss or damage. You are also requested to register an FIR and submit to any appropriate body of the state government to grant us the compensation that we need to rebuild our lives.
