With due respect, I would like to lay down the following lines before you for your kind consideration and necessary action.

That, due to the recent violence in Imphal and adjoining areas, I have left my rented home and locality on the 3<sup>rd</sup> May, 2023 to my safety place by locking my house and go down store.

However, on the 26<sup>th</sup> February 2024 at around 11:30 AM, miscreants belonging to Meitei community in the name of Arambai Tengol have broke the doors and keys of my rented home located at the house of one Mr. Thangkhogin Touthang of 2<sup>nd</sup> street New-Lambulane, Imphal East. The miscreants have looted all my household properties including electronic items, kitchen & utensil items, clothing and apparels, furniture and important documents. The miscreants have also completely looted my go down store containing 120 nos of 2<sup>nd</sup> hand belt. The approximate value of lost and looted properties is estimated to be about Rs. 43 Lakhs.

The incident could not be reported to my concern Police Station due to the prevailing Law & Order situation in the State.

I, therefore kindly request you to take necessary action in this regard. Thanking You.
