Respected Sir,

With due respect I would like to state that a large number of unidentified group of people belonging to Meitei community with deadly weapons and arms stormed to all the Kuki inhabited area in the state from 3rd May 2023 onward.

Due to the ethnic violence in the state. I have run for my live leaving behind my rented house along with my household items and belonging to the address owned by Mr. Lungoumang Touthang at 2nd New Lambulane near UPC Church, Imphal about 34km south from Saikul-PS .

Received an information from a reliable sources that, on 20th February 2024 some unidentified Meitei forcefully enter, destroyed and looted my rented house, taking all my valuable items. Kitchen items. Laptop. Money, clothes, furniture, electronic devices, books, study materials, documents, educational certificates and other things.

The approximate value of the lost property is about Rs.5,00,000/- (five lakhs).

Due to lack of legal knowledge , I could not report the incident in time to the concerned authority.

I therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.




