Due to the ethnic violence in the state. I have run for my live leaving behind my rented house along with my household items and belonging to the address owned by Mr. Lungoumang Touthang at 2<sup>nd</sup> New Lambulane near UPC Church, Imphal about 34km south from Saikul-PS.

Received an information from a reliable sources that, on 20<sup>th</sup> February 2024 some unidentified Meitei forcefully'enter, destroyed and looted my rented house, taking all my valuable items. Kitchen items. Laptop. Money, clothes, furniture, electronic, devices, books, study materials, documents, educational certificates and other things.

The approximate value of the lost poperty is about Rs.5,00,000/-(five lakhs).

Due to lack of legal knowledge, I could not report the incident in time to the concerned authority.

I therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
