With regards, I am to state that I, the undersigned along with my family have left the residence on 5th May for our physical safety and the house and property will be protected by security forces who will be on duty 24x7.

That, in pursuance of the above stated order, the Commissioner (Home), Government of Manipur also issued an order no. H-3608-Hd dated the 16th October, 2023 in the name of the Hon'ble Governor of Manipur directing all relevant Deputy Commissioner and Superintendent of Police to implement the said direction of the Hon'ble Supreme Court of India.

That, inspite of the aforementioned order, I have come to learn from reliable source that my house has been encroached and illegally occupied and robbed between 25th February to 2nd March by Arambai Tenggol/ UNLF which is worth about Rs.19,66,000. Home loan of Sixtyfive lakhs for construction was also received from UCQ Bank Thangal Bazaar, Imphal in 2019.

In view of the above stated facts, I request you to kindly take up necessary legal action.
