Subject:- Complain/Report of illegal encroachment/occupation and robbing household properties of my residential house at New Lambulane Patta no. 788(old) & 106 (new), 26 (A) Nongpok Ingkhol, New Lambulane 1st street by Arambai Tengol Unit – 8 (U-8).

With regards, I am to state that I, the undersigned along with my family were forcibly evacuated by the central and state security forces on the midnight of sept, 1, 2023 for our physical safety and the house and property will be protected by security forces who will be on duty 24x7.

That, the Hon'ble Supreme court of India passed an order on 25th September, 2023 directing the state government to ensure protection of the properties of the displaced persons and prevent their encroachment.

That, in pursuance of the above-stated order, the Commissioner (Home), Government of Manipur also issued an order no. H-3608/2/2023-HD-HD dated the 16th October, 2023 in the name of the Hon'ble Governor of Manipur directing all relevant Deputy Commissioner and Superintendent of Police to implement the said directions of the Hon'ble Supreme court of India.

That, inspite of the aforementioned orders, I have come to learn reliable source that my house has been encroached and illegally occupied and robbed of my scooter, bed, fridge, furniture, household properties, important document (original certificate of matriculation, HSSLC and Graduation of my son). etc. between 21st, February to 29th February by Arambai Tengol (U-8) which worth is about Rs. 23,94,000 /-

In view of all the above – stated facts, I requested you to kindly take up necessary legal action.




