



With due respect, I the undersigned have the honour to state on 16/03/2024 at around 9:00pm, my younger brother Md. Akbar khan aged about 38yrs and my nephew Md Rohit Khan aged about 26yrs S/o Md. Feroz khan of khomidok Mayai Leikai. I/E went out from their residence to buy some eatables from nearby shop by driving one Maruti Gypsy B/ regd No. WB-74G-8841 white in Colour, but they did not turned up at home till today 17/03/2024. our family member had also tried to trace out their whereabouts but in vain. However today i.e. 17/03/2024 at around 3:00 pm from one unknown number 897439410 called to Md. Feroz Khan (father of Md. Rohit) number 9366636754 and intimated that his son Md. Rohit & Md Akbar were kidnapped by them and demanded a ransom of Rs 15,000,00/-(fifteen Lakhs only) to be paid today 17/03/2024 before 8:00pm and threatening that if the said ransom amount is not paid they will kill them.

The above mentioned victim Md. Rohit and Md. Akbar mobile no. 9863038724 & 7005347324 were also found switch off.

It is therefore requested to kindly traced out the kidnapped persons and to booked the culprits involved in the instant crime.
