With reference to the above cited subject, I, Suman Debnath, an incharge Imphal bound vehicle by profession, would like to inform your esteem authority that on 17th of March 2024, around 1715 hrs, while I was standing at NRL petrol pump MANTRIPOOKHRI, IMPHAL, a maroon color car - Creta without number plate, with 4 occupants with weapons (pistol), stopped near me, on gun point forcefully they kidnapped me.

They were all armed with pistols and threatened to kill me they said to me, -SMS and clear all due before coming to imphal town.

They provided me with a mobile no- 8974683651, G5 GROUP UNDERGROUNDS and asked to send them sms with vehicle details when even I bring any vehicle to imphal.

They released me at around 1816 Hrs after forcefully taking ₹6000/-that I had with me in cash. They have also said that they belong to an underground group by the name G5.

Sir, looking into the seriousness of the matter, I request you to kindly lodge an Fir against those unknown miscreants and do the needful so that the culprit can be apprehended.
