I the undersigned, Range Forest Officer, Sawombung Range have the honor to state that while enclosing a report from Forest Beat Officer Napet Palli, on daily duty of patrolling by staffs of Forest Beat Office Napet Palli at Khema Reserved Forest and its surrounding on 23rd December, 2023, an illegal felling of trees for use of firewood at compartment No. 6 of Khema RF nearby Nongren village is found.
