Namjoklung School along NH-202, Imphal-Ukhrui road while the Tractor was proceeding towards Lamlong side. As a result of which the unknown lady received injuries on her person and evacuated to JNIMS Hospital for medical treatment. Later, the lady was declared brought death by the concerned doctor.
