Today i.e. 17/01/2024 at around 08:00 PM received information that some armed persons suspected to be Kuki militants attacked State forces attached at Keithelmanbi Out post by using sophisticated weapons including bombs from Bongbal Khullen, Keithelmanbi side at State forces. In that the State forces also retaliated firing with large nos. of ammunition. The exchange of firing lasted till at around 10:50 PM. The Office buildings and barracks of the above mentioned Out-Post were found damaged. However no casualty report has received so far.

While searching the area 3(three) nos. of un-exploded bomb were found in and around of Keithelmanbi Out-Post (Police).

Hence, in this regard a Suo Motto case under FIR.NO. 05(01)2024, TBL-DAM-PS, u/s: 147/148/149/427/34-IPC and 5-Expl. Subs. Act has been registered.
