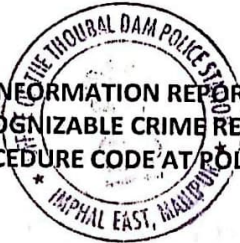

Today i.e., on 18/01/2024 at around 02:00 pm to 09:00 pm, an exchange of firing in between some unknown armed persons suspected to be Kuki militants and some valley based UGs at Maphou Kuki village hill slope south eastern side Kangpokpi district about ½ Km north west from Police Station by using sophisticated automatic weapons including bombs in that one village volunteer by the name of Sorokhaibam Ibochouba Singh aged (34) yrs. S/o- S. Ibungoton of Tumukhong Makha Leikai, Imphal-East got serious injuries due to bomb splinter on his person and evacuated to Shija Hospital, Lamphel for medical treatment. While discharging the duty by the security forces, the mob obstruct the forces. Moreover six houses were also partly burnt down at the foothill of the said village. In that to control the prevailing situation of the exchange firing the troops of 1/3 Gorkha Rifle and 29 Bn.BSF retaliated firing several rounds Hence a sue mottu case has been registered under **FIR No. 06 (01)2024 TBL-DAM- PS, U/S:147/148/149/186/307/326/427/448/436/34-IPC & 25(1-C)A.Act & 3-Expl.Subs.Act** for investigation.
