LODGING OF FIR AGAINST MEIRA PAIBIS AND AARAMBAI TENGGOLS

1. At around 0800 hrs on 01 Jan 2024, a group of more than 100 of Meira Paibis and Aarambai Tenggols, armed with illegal weapons and vehicles, attempted to attack Maphou village (GR 609905), a Kuki ethnic group village in Imphal East District of Manipur. Security Forces Columns deployed in the area Maphou (GR 616901) and Island (GR 603857), intervened to protect the villagers and prevent the violence. However, they faced resistance and obstruction from the Meira Paibis, who blocked their movement near Tumukhong village (GR 609895). The Meira Paibis also prevented movement of reinforcing parties of Indian Army, Police and Rapid Action Force (RAF) from reaching the location by putting up blocks at different locations incl points Moirangpurel (GR 600868), Itham (GR 607853), Oksu (GR 564912), Hanuman Top (GR 557925) and Nongren (GR 553937) leading to Maphou, thereby preventing the Security Forces from taking the legal course of action.
2. The Meira Paibis along with Aarambai Tenggols who were wearing black clothes and prevented the Security Forces from any movement and pursuing the legal course of action. They formed a human chain and barricaded the road with vehicles and logs.
3. By 0930 Hours, there was further influx of more than 200 vehicles towards Tumukhong Village Community Hall. The a/m mob comprising suspected cadres could be seen building up inside the Tumukhong village. However, entry of the Security Forces into the village was blocked by the Meira Paibis of Nongren, Oksu, Nongdam, Itham, Moirangpurel and Tumukhong villages by establishing dedicated road blocks as in Para 1 above, thereby preventing all reinforcements of Security Forces Columns from reaching Maphou.
4. In view of the above, **FIR against unknown/ Unidentified rioting Meira Paibis & other rioters including Aarambai Tenggols in general area Nongren, Oksu, Nongdam, Itham, Moirangpurel and Tumukhong villages** may be lodged for the following offences :-
 - (a) Obstructing Public Servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to the aforementioned provision incl Sec 353, 503, 504 and 506 of the IPC (against Meira Paibis).
 - (b) Obstructing the Public servants in apprehending the armed miscreants and unlawfully resisting their arrest and intentionally attempting to snatch weapons from Indian Army while performing a bonafied duty in Aid to Civil Authority contrary to Sec 201, 224 and 225 of the IPC (against Meira Paibis).

(c) Assisting /aiding escape of the armed miscreants from the lawful custody of Indian Army while performing bonafied military duty in Aid to Civil Authorities contrary to Sec 201,224 and 225 of the IPC (against Meira Paibis).

(d) Criminal Intimidation, Assault and Criminal Force against Public Servants discharging public duty in Aid to Civil Authorities contrary to Sec 34,120,332,350 and 353 of the IPC (against Meira Paibis and Aarambai Tenggols).

(e) Instigating and abetting Unlawful Assembly of rioting Meira Paibis and locals to obstruct the Army in performance of their lawful duty on at 0800 hrs contrary to Sec 34,120,147,353 and 505 of the IPC (against Meira Paibis).

(f) Possession of illegal arms and ammunitions contrary to Sec 25 (1C) and Sec 27 of Arms Act, 1959 (against Aarambai Tenggols).

(g) Rioting while being armed with a deadly weapon or with anything which, if used as weapon, is likely to cause death contrary to Sec 146,147,148 and 149 of the IPC (against Aarambai Tenggols).

5. It is requested that the action taken post registering of FIR and identification as well as initiation of legal action in r/o perpetrators of above crimes be intimated in laid down time frame (without waiting for invoking RTI). Copy of FIR & Police report be handed over to the pers filing FIR under Section 173 (2) (ii) of CrPC 1973.

6. In this regards, your attention is drawn to The Hon'ble Supreme Court ruling in Lalita Kumari Vs Govt of UP (MANU/SC/1166/2013) where it is has held "it is mandatory to file the FIR u/s 154 of the Code if the information discloses the commission of a cognizable crime and no preliminary Investigation is permissible in such a case".
