Today i.e. 13/02/2024 at 8:35 pm received a reliable information that on the same day at about 8.30pm an unruly mob mostly youths numbering about 1000 individuals stormed at the camp of 5th Indian Reserve Battalion located at Chingarel Tejpur and snatched away several arms and ammunitions. Sound of gun shots were also heard at Chingarel Tejpur area. A strong team of District Police rushed to the spot and engaged with the violent mob. Some youths armed with sophisticated weapons fired towards the police team to which the Police team also retaliated by firing several rounds.

Hence, a suo-mottu case under FIR No. 7(2)2024 LLI-PS U/S 144/147/149/379A/427/447/34 IPC, 25(1-B)A Act & 16 UA(P) Act. has been registered for investigation.
