



With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Vaiphei Tribe, which is a recognized tribe under the Constitution of India and a resident of House No. 28/A, 3rd Floor, (L) Lengpau Building/Apt., New Checkon, P.O. & P.S- Porompat & district- Imphal East, Manipur.

That, due to the ethnic crisis in the state of Manipur, we deserted our rented house located at the above mentioned address, owned by namely- **Nengting (9402678556)** on the **4th of May, 2023** at around **5:00 AM**, that a group/mob of majority Meitei/Meiteis suspected to be members of Armabai Tenggol, Meitei Leepun and the locals in and around the area, attacked our locality and in the process, they have looted & vandalized all my household items/ movable assets including our original documents, and arson-attacked/ torched my rented house on the **4th of Jan., 2024** at around **9:30 PM**.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.14,35,500/- (Rupees Fourteen Lakhs Thirty-Five Thousand Five Hundred)** Only, exclusive of the rented house/apartment.

That, I humbly pray you to kindly register a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
