Today i.e. 17/03/2024 at 06:21 pm received an information that on the same day at about 06:10 pm one Honda Activa bearing Regd. No. Nil (White in colour) ridden by unknown rider, which was coming from Sawombung side towards Lamlai side, along NH-202 (Imphal-Ukhrul road) and One Royal Enfield Hunter 350 B/Regn. No. MN01AN2829 (Black in colour) which was coming from same direction were knock down by one unknown yellow colour bus at Nungoi Loukut along NH 202 (Imphal Ukhrul road). Both the vehicles were badly damaged. As a result of which the two riders and two pillion riders of both the vehicles received serious injuries on their person and evacuated to hospital for medical treatment.
