Subject: First Information Report regarding the looting and malicious damage of my house by unknown miscreants.

Sir,

With reference to the above cited subject, I have the honour to file this First Information Report which I do as under:

1. That, I am the resident and owner of my house situated at New Lambulane, Imphal, P.O. & P.S. Porompat, Imphal East District, Manipur, covered by Pucca Patta No. 35570/370 (New) 1187/ 1888 C.S. (29) 5413/ 5623 under Revenue Village No.- 26(3) Nongpok Ingkhol, standing in the name of Sylvia Neinou Haokip, D/o L.K. Haokip, New Lambulane, Imphal, P.O. & P.S. Porompat, Imphal East District, Manipur.
2. That, it has come to my knowledge that on the intervening night of the 18th January, 2024 and the 19th January, 2024, some unknown miscreants have broken my door open and looted and damaged my belongings. They have also maliciously damaged parts of my building hence rendering it inhospitable. The rough details and estimate of the loss caused by the malicious attack is given in the schedule herein below.

I, therefore, pray you to kindly accept my report and register an FIR against the malicious attack narrated above. And, your honour may be pleased to investigate the matter and book the culprits according to the laws of our country. And, for this act of kindness, I shall always remain thankful to you and obliged.
