





Subject:- Request to take appropriate action against Shri Hmangte Lamlen Kom aged about 42 years S/o Late Khumneibung of Sagang Village, P.O. Moirang & P.S. Kumbi, Churachandpur District, Manipur-795133 for continuous sexual exploitation by giving false promises to marry me.

Madam,

I have the honor to lay down the following few lines for your kind perusal and necessary actions:-

1. That, I belong to Sagang Village, P.O. Moirang & P.S. Kumbi, Churachandpur District, Manipur:795133 and at present residing at rented house of Md. Riyazuddin Khan located at Mantripukhri Muslim Colony, P. Mantripukhri & P.S. Heingang, Imphal East District, Manipur: 795002.
2. That, I and the accused are residence of Sagang village, Churachandpur District, Manipur and we have known to each other since our childhood. I and the accused had a love affair since 1993 and we eloped on 31-05-1994. However at the time of our elopement I and the accused were minors as such we were separated by our respective families with a promise that we would get marry as soon as we attained major. Even after our separation by our respective families we kept on meeting each other very frequently. Thereafter, the accused person visited my residence very frequently after the accused joined his service in the year 2011 as warder in the jail Department, Government of Manipur and the same continued till 2015. In June 2015, I was conceived and accordingly I informed to the accused through mobile phone and accordingly the accused person came to my parental house at Sagang, Churachandpur District, Manipur and took me at Imphal (Sajiwa jail barrack) and thereafter, he gave pill/medicine for abortion of conceived child forcefully without my consent and accordingly aborted the conceived child. Thereafter, on 25-11- 2015 the accused person brought me at Imphal and stayed at the rented house at Hatta, Imphal East opposite to oil pump and we lived together till 09-09-2016 at the said rented house and on 09-09-2016 we again shifted at Mantripukhri Muslim colony, Imphal East owned by Md. Riyazuddin Khan of Keikhu Maning Leikai,



P.O. Mantripukhri, P.S. Heingang, Imphal East District, Manipur -795002 and lived together at the said rented house till 31-01-2022 with the false promises that we would get marry as soon as possible. The accused in order to exploit me sexually managed to give a false promises by preparing many documents and the latest being the affidavit which was signed by me and the accused on 05- 03-2021 before the Oath commissioner, Manipur at Cheirap court complex that we eloped with mutual consent out of love and affection. By doing so, I was sexually exploited repeatedly by the accused person with believe that he would marry me. I and my family members kept on trying to convince the accused and his family to marry me. However, there was no fruitful outcome. As such, I could not report on time as I was engaged in approaching different legal authorities

I therefore, request you to kindly take appropriate action against the accused person for repeated sexual exploitation with the false promise to marry her.
