



Subject : Report.

Sir,

I have the honour to state that, I the undersigned aged about 32 years occupied a rented house at New Lambulane, New Checkon Imphal East District, Manipur.

That, On 3/05/2023 due to sudden broke out of communal conflict in Manipur, self alongwith my family have left our rented house and fled to a nearby safe location at 1<sup>st</sup> BN. Manipur Rifles and later on evacuated to Kangpokpi District by the Central Security force. And now temporarily shelter in relief camp at Shongthu Avenue Saikul, Kangpokpi District, Manipur.

Further, it is learnt from a reliable source that, on 28/11/2023 at around 11:30 am some unknown miscreants have vandalised my rented house and looted all the valuable and moveable properties.

Some of the list of properties destroyed or loss are mentioned in the **Annexure (enclosed)**. The Approximate value of lost properties is calculated at about Rs. 4,19,000/- (four lakhs nineteen thousand ) only.

Due to lack of legal knowledge I could not report to the concern authority in time.

It is, therefore, requested to kindly register a case and take necessary legal action against the culprits according to law.
