



I beg to state that, I the undersigned aged about 25 years owned a pucca house at 2nd Street New Lambulane also known as New Checkon under 15- Wangkhei Assembly Constituency.


That, following 3rd May, 2023 violence in Imphal valley, we were all evacuated from Imphal leaving behind my house and all the household items. Further, received a reliable information that, my house have been vandalised and damaged and all the household items including valuable jewellery have been looted by some unknown miscreants. The incident is believed to be occurred between 4th May to 6 May 2023 at night.

The list of properties are loss or destroyed are enclosed in the annexure. The approximate value of the loss and damaged properties including the land valuation as per own assessment is calculated at Rs. 2.45.00,000/- (Two crores forty five lakhs).


Due to lack of legal knowledge I could not report the incident in time.
