



With due respect and regard I would like to inform you that I along with my family have fled and left my residence i.e. New Lambulane, 3rd Street, Hmar Veng, Imphal East P.S Porompat on 4th May, 2023 due to the ethnic violence that erupted in the state to save our lives. It has come to my knowledge that on 21st Nov. 2023 some unknown miscreant have entered my house and looted my property worth Rs. 15,00000/- (fifteen lakh) including Beds, Almirahs, Arm benches, Chairs, Gas Cylinders, Refrigerator, Washing Machine, Television, Tv stand, Dining Table, Water reservoir, Computer, Laptops, Blanket, Gold Ornaments, Kitchen items, Electronic Gadgets, Clothing, Tuition class tools and materials, Scotty Activa 5G etc.

I therefore request you to registered an FIR against the culprits and take up necessary legal action regarding the incident.
